Non-Pledge Receipts

These donations are tracked and statements provided to donors.



General Fund Composition of Revenue

Loose Plate Offerings

Collected that are not from identifiable donors, such as cash in the plate that was not inside an envelope with a name of the donor.

Other Income

Includes investment income, church rental income, wedding income, initial envelope offerings and miscellaneous income.

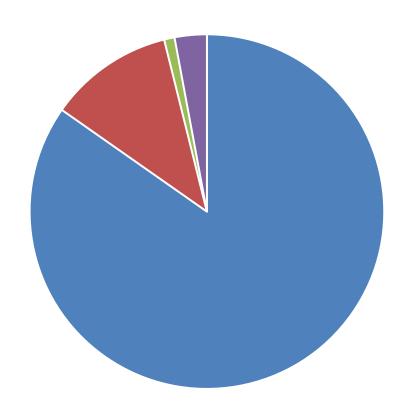

Worship - 0.12%

Expenses include worship supplies, chancel and sanctuary appointments and sound/video equipment repairs

Evangelism - 0.39% Supplies, Upper Room booklets, van/bus gas and oil, Anchored ministry, church-wide programs, men's outreach

Education Ministry - 1.50% Education supplies, Sunday School supplies/curriculum, youth curriculum, training and special projects



Nursery and Childcare - 0.84% Child care wages and supplies

Missions / Church & Society - 2.34% Missionary support, VIM support and local agency support (Habitat, Safe Harbor, FIA & BSA)

Music Ministry - 2.90% Music, accompanists, workshops, wages for part-time directors and worship leader, supplies and repairs



Youth Ministry - 2.10%

Youth ministry supplies, graduation gifts, mission work expenses, advisor training, youth fellowship activities, Winterfest costs and confirmation expenses

Food Service - 0.68%

Wednesday at Wesley meals (net of offsetting revenue), coffee hour supplies (net of offsetting revenue), kitchen supplies, Wesley special events and non-church catered events



Salary Expense - 52.91% Expenses include pastors and staff (full and parttime) salaries and overtime

Employee Benefits -12.87%
Pastoral housing, travel, phone and pension costs; staff travel, retirement and insurance benefits, payroll taxes, worker's compensation insurance

Training and Conferences - 0.67% Continuing education, conferences and staff retreats



Consumable Supplies - 0.39% Office supplies and paper

Maintenance and Utilities - 8.13% Custodial supplies, utilities, telephone, software/hardware support, pest control, garbage disposal, snow removal, lawn maintenance and equipment repairs

Communications & Publicity - 2.49% Postage, brochures, newsletter printing, postage machine lease, advertising, website



Conference Apportionments -11.40% UMC conference support, benevolence, connectional ministries and clergy/administrative support

Miscellaneous Expense - 0.17% Bank charges, copyright licenses, accounting and auditing costs and other non-classifiable expenses



Trustees' Fund Composition of Revenue

Farm Income Rental income collected on the 306 acres of farm land owned by the church

Investment Income Income generated by the investments held in the Trustees' fund. Includes interest, dividends, realized/unrealized gains, losses in the portfolio

Building Fund Donations
Periodic donations designated as "building fund" gifts.
Posted with the intention of being used for the
maintenance/upkeep of church facilities

Undesignated Memorials Undesignated will bequests, memorials for those who request a donation be made to Wesley in lieu of flowers

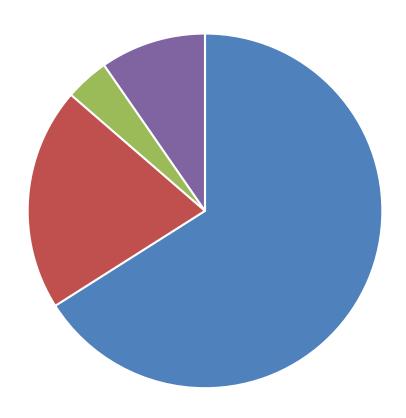

Trustees' Fund Composition of Expenses

Salary and Benefits Expense - 23.11% Expenses include facilities manager salary and payroll taxes

Building Repairs and Maintenance - 28.52% Expenses include any repairs and upkeep outside of the normal maintenance of the facilities

Building and Vehicle Insurance -16.02% Insurance for building, facilities and church vans/busses



Trustees' Fund Composition of Expenses

Real Estate Taxes - 6.99% Real estate taxes for the farm properties

Technology Upgrades - 2.41% Hardware upgrades and other IT upgrades required for the church

Landscaping - 1.20% Landscaping costs for the church and facilities



Trustees' Fund Composition of Expenses

Other Expenses - 2.44% Security expense for the church facilities and parsonage expenses

Capital improvements -19.31% Improvements to the church building and facilities that are not considered ordinary repairs and maintenance costs
